## ● Objectives

Our doctoral program aims to make our students acquire the following abilities:

- Ability to consider and investigate effective ways of public relations, organization construction, and linguistic communication in this highly information-oriented society
- Ability to construct methods of contributing to creation of local communities in the context of active mobility of humans and cultures
- Ability to discover and manage the values of local resources, and create ways to make them public and realized in a global scale

## ● Admissions Policy

This doctoral program is open to students who are enthusiastic about developing their knowledge and intellect regarding media-communication and tourism for the purpose of helping to solve challenges of contemporary society in which the advancement of information technologies is in progress and intercultural interactions have become everyday events with the increasing movements of people. Diverse students, including adults and international students, are actively accepted. This doctoral program is specifically open to the following students.

- Students who have the focused intention of autonomously conducting research on the basis of advanced technical knowledge about tourism and media-communication. Thus, the students must be able to accurately analyze actual issues that beset the contemporary world toward developing cutting-edge models that will help to solve these issues.
- Students who are eager to engage in the development of networks and organizations that are useful for encouraging diverse actors from the academic, business, governmental, and private sectors to collaborate with each other. Thus, the students must be able to creatively conceptualize

systems for facilitating external and internal communication and exchanges for the purpose of helping local people to live with pride in, and attachment to, their communities.

Students, with the above intentions, are expected to have acquired the knowledge/skills, thinking/judging/expressing abilities, and the attitude to learn in collaboration with various people to conduct research activities, through daily studies, work and social life.

[Basic policy for student selection]

<Doctoral Program>

Oral examinations based on submitted research plans and master's thesis comprehensively evaluate communication skills, knowledge, thinking skills, expressive skills, and attitudes towards cooperating with diverse people, which are necessary to examine highly specialized research topics and to present results of studies.

## I. Examinations for General Admission, Admission for Adults, and Admission for International Students

### 1. Number of Students to be Admitted

### 2. Eligibility for Application

General admission	<u>The applicant satisfies any of the eligibility requirements (1) ~ (8) below.</u>
Admission for adults	<u>The applicant satisfies any of the eligibility requirements (1) ~ (8) below, plus either (a) or (b) described below.</u> (a) The applicant is currently serving in public office or is working for a company, an association or a school and aims to complete the doctoral program during his/her tenure of office. (b) The applicant has at least 2 years of work experience or will have earned a degree at least 3 years before the time of enrollment.
Admission for international students	<u>The applicant does not possess Japanese citizenship but does satisfy any of the eligibility requirements (1) ~ (8) below.</u>

- (1) The applicant has completed, or is expected to have completed by September 30, 2026, a Master's or Professional degree.
- (2) The applicant has completed, or is expected to have completed by September 30, 2026, a degree equivalent to a Master's or a Professional degree at a university in a country other than Japan.
- (3) The applicant has completed, or is expected to have completed by September 30, 2026 a degree equivalent to a Master's or a Professional degree after finishing a correspondence program provided by a school in a country other than Japan while residing in Japan.
- (4) The applicant has completed, or is expected to have completed, a graduate program of an educational institution in Japan that has been certified by the Minister of Education, Culture, Sports, Science and Technology and which provides courses for a foreign graduate school within the school education system of that foreign country, and the applicant consequently has been or is expected to be conferred with a degree equivalent to a Master's or a Professional degree by September 30, 2026.
- (5) The applicant has completed or is expected to have completed a program at the United Nations University that was established in accordance with the United Nations General Assembly resolution of December 11, 1972, as set forth in Paragraph 2, Article 1 of the "Act on Special Measures Incidental to Enforcement of the Agreement between the United Nations and Japan Regarding the Headquarters of the United Nations University" (Act No. 72 of 1976), and the applicant has been conferred or is expected to be conferred with a degree equivalent to that of a Master's degree by September 30, 2026.
- (6) The applicant has followed a curriculum at a school abroad, an educational institution specified in eligibility item (4) above, or the United Nations University, has passed examinations and screening equivalent to those specified in Article 16 of the Standards for Establishment of Graduate Schools, and has been recognized as having academic ability at least equivalent to those who have a Master's degree, or the applicant is expected to be recognized as such by September 30, 2026.
- (7) The applicant falls under either of the categories 1) and 2) below that were specified by the

Minister of Education, Culture, Sports, Science and Technology in ministerial notification No.55 of 2001. (\*1), \*2))

- \*1) The applicant has graduated from a university, has engaged in research at a university, a research institute or other institution for at least 2 years, and has been recognized by the Graduate School of IMCTS as having academic ability at least equivalent to those who have a Master's degree in light of the results of said research.
  - \*2) The applicant has completed at least 16 years of school education overseas or has completed at least 16 years of a correspondence program provided by a school in a country other than Japan while residing in Japan, has engaged in research at a university, a research institute or other institution for at least 2 years, and has been recognized by the Graduate School of IMCTS as having academic ability at least equivalent to those who have a Master's degree in light of the results of said research.
- (8) The applicant has been recognized by the Graduate School of IMCTS as having academic ability at least equivalent to those who have a Master's or Professional degree on the basis of an individual admission qualification screening, and the applicant will have reached the age of twenty-four (24) by September 30, 2026.

#### • **Special Educational Methods Pursuant to Article 14 of the Standards for the Establishment of Graduate Schools**

The Graduate School of International Media-Communication and Tourism Studies has a system that provides “Special Educational Methods Pursuant to Article 14 of the Standards for the Establishment of Graduate Schools” to students who have a job or who need a special educational method. By taking advantage of this system, students can learn flexibly with the approval of and under the supervision of a doctoral supervisor on the basis of the curriculum specified in the rules and regulations of the Graduate School of IMCTS.

Cf. The Standards for Establishment of Graduate Schools (Education Ministry Ordinance No. 28 of 1974)  
Article 14 (Excerpt)  
When a special need is acknowledged from an educational viewpoint in a graduate program, education may be provided by appropriate means, for example by giving classes and research guidance during evening hours, at other specific hours, or at a certain time of year.

### **3. Need for Preliminary Review of Applicant Eligibility**

Applicants who fall under categories (3), (4), (6), (7), or (8) in “**2. Eligibility for Application**” above are subject to a preliminary review of their eligibility prior to a period during which application forms are accepted.

The applicants are required to contact the Academic Affairs Division, Administration Office, IMCTS at [nyuushi@imc.hokudai.ac.jp](mailto:nyuushi@imc.hokudai.ac.jp) by May 31, 2026, to obtain information on how to register for a preliminary review.

\*The registration website (English version) does not support the preliminary review.

#### **<Document submission period - preliminary review>**

**Monday, June 1, 2026 from 10:00 through Friday, June 5, 2026 at 17:00/5 p.m.**

(Application documents, etc., sent either by post or submitted in person, must arrive no later than 17:00/5 p.m. on Friday, June 5, 2026.)

**Applicants who are subject to a preliminary review shall not make payment of the examination fee until they are notified of the preliminary review results.** A notice of preliminary review results will be sent by email to each applicant concerned. Applicants that qualify for the entrance examination shall apply for the Graduate School of IMCTS, following the instructions in “4. Application Procedure, etc.” Applications will not be accepted from applicants who fail to make payment of the examination fee within the specified period of time.

#### **4. Application Procedure, etc.**

Applicants who apply for the Graduate School of IMCTS must follow all the steps ① through ③ within the specified period. Applications will be rejected if the applicants fail to complete all of the steps within the specified period of time.

##### **②Payment of examination fee**

After the applicants register for the online application for the Graduate School of IMCTS, they are required to pay an examination fee (30,000 yen) and a transaction fee (500 yen). Postal and bank payments are not permitted. Applicants are required to pay the fees using one of the approved methods listed below. Reconfirm the payment details on the online application site.

- credit card
- internet banking
- convenience stores
- bank ATMs with Pay-easy transaction services
- UnionPay Online Payment

\* Applicants who are expected to complete a Master’s or Professional Degree Program at the Graduate School of IMCTS (or at another Graduate School of Hokkaido University) and Government(or University)-sponsored international students are exempt from the examination fee. After registering for the online application on the website, those students should skip the second step (②) Payment of examination fee and complete the online registration procedure. The applicant is expected to notify the Academic Affairs Division, Administration Office, IMCTS, by email at [nyuushi@imc.hokudai.ac.jp](mailto:nyuushi@imc.hokudai.ac.jp) upon completion of the online application registration. The email must include the applicant’s name, academic affiliation, and student ID number.

##### **[Refund of examination fees]**

Examination fees will only be refunded as set forth in the following cases: ① An applicant paid the examination fee, but the applicant did not apply for the Graduate School of IMCTS. This usually means the applicant did not submit the application documents or the application was rejected. ② The applicant mistakenly paid the examination fee more than once.

\* Even if the examination fees are paid, applications will not be accepted from applicants who fail to submit the application documents within the specified period of time.

### ③Submission of application documents

After the applicants pay the examination fees, they are required to download PDF files of the application form, and resume. Complete these files, combine them with “8. Application Documents, etc.” into one PDF file, and email it to the Academic Affairs Division, Administration Office, IMCTS, at the following address: nyuushi@imc.hokudai.ac.jp within the period specified in “(1) Period for online registration ...”.

\* Applicants will not be permitted to download application forms or other documents until they pay the examination fees.

\* Applications will be rejected if the applicants fail to email the application documents PDF file within the specified period of time.

After these documents have been emailed, print them in color. Submit them with “8. Application Documents, etc.” within the period specified in “(2) Period for accepting application forms” to “(3) Where to submit application documents” either by post or in person.

## **5. Selection Process and Examination Schedule**

### **General entrance examination, admission examination for adults, and admission examination for international students**

Applicants will be selected on the basis of the following: submitted documents, including their academic transcript; Master’s thesis or equivalent research achievements (or performance report in the case of applicants for admission for adults (submission can be on a voluntary basis)); research plan; and oral examination.

Examination content: The oral examination will be based on the Master’s thesis (or equivalent research achievement) and the research plan of the applicant.

The oral examination will be given in Japanese, in principle. When deemed necessary for the applicant’s research, the applicant’s competence in another language(s) might be tested.

In the admission examination for adults, the applicant’s professional expertise related to the applicant’s career might be tested.

## 6. Announcement of Successful Applicants

For every successful applicant, the examinee’s number will be posted on IMCTS’s website on the date shown below. All applicants will be informed of their examination results in writing. (Telephone and e-mail inquiries will not be accepted.)

## 7. Admission Procedures

Documents necessary for admission procedures will be sent to successful applicants at the time of the announcement of acceptance. The period for admission procedures is currently scheduled to Mid- September, 2026.

## 8. Application Documents, etc.

All application documents shall be written in Japanese or English.

Note: Use of ink that disappears after being rubbed by a rubber eraser (such as the ink of FriXion erasable pens) is not allowed. Be sure to use a permanent ballpoint pen to fill out the forms.

When the original certificates are written in a language other than Japanese or English, then a Japanese or English translation of these certificates shall be certified by a public agency of the applicant’s home country and shall be attached to the certificates concerned.

Note: A “public agency” means an embassy or other government agency, or a university or other educational institution.

## **II. Admission Fee and Tuition**

- (1) Admission fee: 282,000 yen
- (2) Tuition: 535,800 yen (estimated amount): Half of this amount shall be paid in the first semester and the balance in the second semester

Notes: 1) When the tuition and fees are revised at or after the student's admission to the Graduate School of IMCTS, revised tuition and fees shall be applied from then on.

- 2) Failure to pay the admission fee within the designated period of admission procedures shall be deemed as admission cancellation.
- 3) The tuition shall be paid in each semester.

## **III. Important Reminder**

- (1) The examination admission card will be sent by email on Tuesday, July 28, 2026. The applicant must print this card and bring it on the day of the examination.
- (2) When it is found that the submitted documents contain false statements, the admission may be cancelled.

## **V. Scholarship Program of the Graduate School of International Media-Communication and Tourism Studies**

The Graduate School of International Media-Communication and Tourism Studies has a scholarship program for applicants who have been accepted to the doctoral program. Applicants who have achieved outstanding results in the entrance examination and have made a commitment to enroll will receive a lump-sum payment equivalent to the admission fee (approx. 282,000 yen) or the half of the admission fee (approx. 141,000 yen) after enrollment.

Scholarship candidates will be informed of their eligibility for the scholarship when they receive an acceptance letter.

## **VI. Eligibility and Application Procedures for Long-term Course Enrollment**

### **1. Aim of the long-term course enrollment system**

Under the long-term course enrollment system, the Graduate School of IMCTS allows students who have applied for the use of the system to spend more years than are typically required for the completion of a graduate program (i.e., 2 years for a Master's program, and 3 years for a Doctoral program.) Eligible applicants are those who have a job or other circumstances that prevent them from securing the study time necessary to earn credits and receive research guidance. These applicants need to submit application documents and a plan for completing the course of study in a specific period of time. The Graduate School of IMCTS processes each application and determines the applicant's eligibility.

### **2. Eligibility for application**

Applicants are eligible for application when 1) they fall under any of the following categories, and 2) they wish to take more years than are typically required to complete a graduate program and to complete their research plan because they cannot concentrate on their studies due to the circumstances stated below.

- (1) The applicant is currently serving in public office or working for a company or other organization (excluding those who are excused from their duties at work and are receiving their pay), is self-employed, or has another kind of full-time job.
- (2) The applicant is working part-time, and the applicant's workload significantly affects the hours available for completing the course of study.
- (3) The applicant is caring for a child or a family member, and the applicant's workload significantly affects hours available for completing the course of study.
- (4) The applicant is physically, visually, hearing, or otherwise impaired, and the impairment significantly affects hours available for completing the course of study over a prolonged period of time.

### **3. Application procedures**

Applicants for the long-term course enrollment system shall include the following documents among their application documents.

- ① Application for long-term course enrollment (Form 1)
- ② Plan for long-term course enrollment (Form 2)
- ③ Documents proving that long-term course enrollment is necessary (e.g. proof of employment, copy of a maternal and child health handbook, etc.)

### **4. Notification of the screening result**

Submitted documents will be examined, and applicants will be notified of the examination results early in September.

### **5. Term of enrollment**

The term of enrollment can be extended in one-year units. In the doctoral program, the total period of enrollment is between 4 and 6 years.

### **6. Tuition**

The annual tuition of a student admitted under the long-term course enrollment system is calculated as follows: [Standard annual tuition] x 3 ÷ [the number of years the student intends to take to complete the course of study]

The annual tuition will be recalculated if the standard annual tuition is revised or if a change to the student's long-term enrollment plan is authorized. There will be no revision to tuitions already paid.

## 7. Change to the number of years for completing a course of study

Under exceptional circumstances, students can make a one-time application for a shortening or extension of the years for completing a course of study.

### (1) Shortening of the period of enrollment

In the doctoral program, the period of enrollment can be shortened to the number of years required for completion of a course of study (= 3 years.)

An application for the shortening of the period of enrollment should be made by the following deadlines:

for a one-year reduction, no later than one year and six months before the end date of the approved extended enrollment period;

for a two-year reduction, no later than two years and six months before the end date of the approved extended enrollment period; and

for a three-year reduction, no later than three years and six months before the end date of the approved extended enrollment period.

### (2) Extension of the period of enrollment

Students can apply for an extension of the period of enrollment in any year other than their final academic year.

In the doctoral program, a course of study should be completed in no more than 6 years.

### (3) The annual tuition will be recalculated in the event that the period of enrollment is shortened or extended. Any overpayment or underpayment will be adjusted according to the years for completing a course of study, but tuition already paid will not be refunded.

## 8. Other

You may apply to the Long-Term Course Enrollment at the time of admission, or at the end of the first academic year or the second academic year. In that case, however, the total tuition will be larger than applying at the time of admission. Note also that you may not apply at the end of the last year.

Please make inquiries with the Academic Affairs Division, Administration Office of IMCTS regarding a request for an application form or questions.

## VII. Score Disclosure from Entrance Examination

Upon request from the applicant, the Graduate School will disclose the examination results of the entrance examination for the doctoral course in accordance with the following procedures.

### 1. Contents of Disclosure

① Score of the oral examination

② Rank of the examinee's score

S = Passing

A = Those within 10 points of the lowest passing score

B = Those within 20 points of the lowest passing score

C = Those within 30 points of the lowest passing score

D = Those whose score exceeds 30 points from the lowest passing score

### 2. Disclosure Method

The Graduate School will respond in writing upon request by postal mail from the claimant.

### 3. Claimant

The person who is the successful or unsuccessful applicant

### 4. Disclosure request procedures

The claimant should enclose the following documents, write “Request for Disclosure of Scores of the Entrance Examination for the Doctoral Program” on the front of the envelope, and send it to the following address.

① Examination admission ticket

If you have lost your examination admission ticket, please attach a copy of your ID (student ID, driver's license, passport, etc.) to replace it.

② Return envelope

(One standard size envelope [23.5 x 12 cm], clearly marked with the address and a 460 yen stamp (including registered postage) affixed)

Within one month from the date of the Announcement of Successful Applicants

### **VIII. Privacy Policy**

- (1) Hokkaido University takes all possible measures to ensure the protection of personal information in compliance with the Law for the Protection of Personal Information Retained by Independent Administrative Institutions and EU General Data Protection Regulation (henceforth, GDPR), on the basis of the Hokkaido University Regulations on Personal Information Management.
